
# **Profile of Directors Retiring 2024**



### 1. Alhaji Rabi'u M. Gwarzo, OON

Alhaji Rabi'u Gwarzo, OON, Chairman of Northern Nigeria Flour Mills Plc started his educational career with a brief stint at Bayero University Kano and proceeded to West Ham College and North East London Polytechnic, both in London where he studied Commercial Accounting between 1972 and 1975.
